EXHIBT "H"

CAREY PROPERTY PROHIBITED USES

The following uses are prohibited on the Carey Property:

- a. Any unlawful use;
- b. Any public or private nuisance;
- c. Any noise or sound audible beyond the boundaries the Carey Property that is reasonably objectionable by reason of intermittence, beat, frequency, shrillness or loudness:
- d. Any heavy industrial use or for a purpose which causes strong or offensive odors, fumes, dust or vapors and/or untidiness; provided, however, that restaurants are not precluded hereby;
- e. Any noxious, toxic, caustic or corrosive fuel or gas;
- f. Any dust, dirt or fly-ash in excessive quantities;
- g. Any use which involves any unusual firing, explosive or other damaging or dangerous hazard (including the storage, display or sales of explosives or fireworks);
- h. Any factory, processing or rendering plant, warehouse or storage facility (except reasonable storage of items, incidental to another permitted use);
- i. Any assembling, manufacturing, distilling, refining, smelting, agricultural or mining operations other than existing agricultural uses as of the date of this Agreement, provided, however, that existing agricultural uses shall no longer be permitted upon completion of the Carey Improvements.
- j. Any trailer court, mobile home park, sales office or lot for sale, rental or leasing of new or used boats, automobiles, motorcycles, trucks, mobile homes, trailers or other vehicles, labor camp, junk yard, stock yard or animal raising or boarding (other than pet supply stores and veterinarian offices that are incidental use in a pet store);
- k. Any dumping, disposal, incineration or reduction of garbage or refuse (other than handling or redacting such waste produced on the Carey Property from otherwise authorized uses and, in such latter event, only if handled in a reasonably clean and sanitary manner);

Any Laundromat or commercial laundry or dry cleaning plant (other than (i) shops serving only as a drop-off or pick up point for a commercial or dry cleaning plant, provided that no cleaning occurs on the premises and (ii) onsite laundry at a permitted hotel, motel or "extended stay suites" that is used solely for the hotel, motel or "extended stay suites" cleaning in connection with the operation of such hotel, motel or "extended stay suites");
